TechShare.Juvenile provides a robust set of features for Advance Case Management, Intake Processing, Institution and Facility Management, Prosecutor Case Management, District/County Clerk and Court functions, and integration for Law Enforcement Agencies, Municipal Courts, and Schools while also providing the ability to access Juvenile data from across participating counties. JCMS.Basic a lighter version of the system provides access to Juvenile data provided by participating counties and the ability to track and report juvenile data to TJJD.

The AMBER, Blue, Silver & Endangered Missing Persons Alert Programs are housed within the Operations Section of the Texas Division of Emergency Management. The State Operations Center (SOC) serves as the state primary control point, collecting and disseminating alert information to local, state, federal, public and private technology partners, known as the State Network. The goal is to mobilize Texas citizens to search for abducted children, missing senior citizens, endangered missing persons and suspects involved with the death or serious injury of law enforcement officers. Each alert program has a specific set of criteria in order to protect the integrity of the network.
