### **Conference Highlights:**

#### **DPS Crime Records Update**

David Gavin is the Assistant Chief of the DPS Administration Division, Crime Records and serves on the FBI's CJIS Advisory Policy Board. Updates on the DPS policies were covered.

#### **DPS Information Security - Technical Audits**

Security Addendum update session was presented by Alan Ferretti. Case studies of other Texas agencies that have been certified will assist other agencies in submitting these NCIC required documents. TLETS security packets are due by August 31, 2008

#### IJIS - Integrated Justice Information System

Representatives of the Governor's Office, Office of Court Administration, Conference of Urban Counties, County Information Resources Agency, DPS, DIR and others discussed the efforts to create a plan and structure for a statewide IJIS.

# TLETS Update-system migration/DL reengineering/FTA Program/ NVPS/LECS

Joanne Jenkins is the DPS TLETS Training Officer with the Telecommunications Section (TLETS). Joanne discussed the new Omnixx TLETS system and migration. She also discussed the new DL reengineering, Failure to Appear Program, National Virtual Pointer System, and Law Enforcement Support Center.

The cut off date for CJIS security is August 31, 2008. The legacy system will be shut down on December 31, 2008.

Agencies that have not migrated to TLETS Force will have TLETS service discontinued.
