New Passport Format for Mexicans Abroad

On October 1st, 2015, the Consulate General of Mexico in Denver and the Consular Network, within the United States, has implemented a new application, a new issuance process, and a new format for Mexican passports. The new passport complies with international regulations signed between the Government of Mexico and the International Civil Aviation Organization (ICAO).

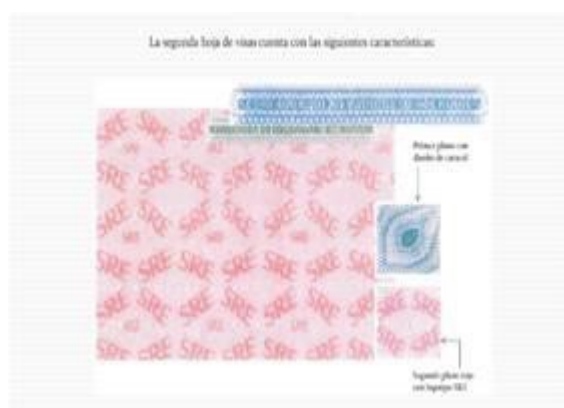
The new passports includes heightened security features to insure that air travel is safer and more efficient. The new passports have been created with the top most technology available to improve its security and reliability for the benefit of our nationals, as well as serving as identification in any legal procedure.

The new graphic design incorporates several features using state of the art software to create patterns such as guilloché, complex designs and linear images.



The current green and gold passport book stamped with Mexico's coat of arms contains 32 pages to represent each State of Mexico. Page two of the current passport book and the data page, contains the bearer's information including a digitized photo, digitized signature, passport number, mechanical reasing and a ghost image.

The data descriptors (e.g. Apellidos/Surname/Nom) are in Spanish, English and French. The pages of the current passport have random fluorescent fibers that appear under UV light. The design on the second and third page of the old passport contain a microtext of the word "MEXICO", holograms, a bar code, and the passport number is printed at the top of every page.



The old versions of the passport will remain valid until its expiration date. At the time of renewal a new passport will be issued, along with 1, 3, 6, or 10 year option format.

What is TCJIUG?

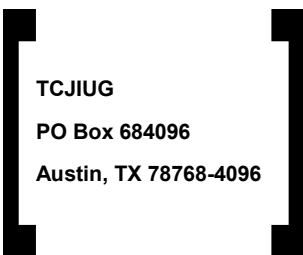
